Subject:- Matter regarding appeal against the denial of Letter of Permission to Mangalayatan Ayurveda Medical College and Research Center, 33rd Milestone Aligarh-Mathura Highway, PO: Beswan, Aligarh - 202145, Uttar Pradesh for the academic session 2021-22.

With reference to the subject mentioned above, I am directed to inform you that **Mangalayatan University-Aligarh, 33rd Milestone Aligarh-Mathura Highway, PO: Beswan, Aligarh-202145, Uttar Pradesh** college has been visited on 08.09.2021 by the visitation team of the, MARB, National Commission for Indian System of Medicine for LOI and as per direction of competent authority Letter of Intent has been issued to you vide letter No. 3-4/2021-Ay(139) dated 07.10.2021 to establish a new Ayurveda college in the name of Mangalayatan Ayurveda Medical College and Research Center, 33rd Milestone Aligarh-Mathura Highway, PO: Beswan, Aligarh - 202145, Uttar Pradesh with 60 seats in BAMS course under Section 29 of NCISM Act, 2020 and relevant regulations there under for the academic session 2021-22.

The Medical Assessment and Rating Board for Indian System of Medicine (NCISM) had carried out an inspection of the institution again on 26.11.2021 for Letter of Permission (LOP) and to assess the available facilities of teaching and practical training for conducting UG (BAMS) course and to verify the compliance of shortcomings informed by the NCISM under section 29 of NCISM Act, 2020 and relevant regulations thereunder.

On examining the same, it was found that the College is not fulfilling the notified and approved criteria for Issuing Letter of Permission (LOP) for 60 seats in UG (BAMS) course, for the Academic Session 2021-22.

Accordingly, under section 29 of NCISM Act, 2020 and relevant regulations there under, and to follow the principle of natural justice as mentioned in the Constitution of India an opportunity of hearing was granted to your college on 17.01.2022 by MARB to present the case through virtual mode.

Whereas, observation of hearing committee based on the submission made by the college and assessment report of the Medical Assessment and Rating Board have been carefully examined in terms of concerned Regulations and it was found that college is not fulfilling following basic eligibility criteria for issuing LOP under section 29 of the NCISM Act, 2020 and relevant regulation thereunder for the academic session 2021-22. Therefore, it was decided by the President, Medical Assessment and Rating Board for Indian System of Medicine to not to issue letter of permission to Mangalayatan Ayurveda Medical College and Research Center, 33rd Milestone Aligarh-Mathura Highway, PO: Beswan, Aligarh - 202145, Uttar Pradesh (Inst. ID AYU0642) with 60 seats in UG (BAMS) course under section 29 of the

NCISM Act, 2020 and relevant regulation there under from the academic session 2020-21 which was communicated to the college vide MARB letter of even no and dated 02.02.2022.

Thereafter, an appeal dated 14.02.2022, was received in the National Commission for Indian System of medicine act, 2020 against the denial order dated 02.02.2022 of Medical Assessment and Rating Board, which was placed before Chairman, NCISM and for same Chairman, NCISM constituted the hearing committee to hear the appeal.

Accordingly, a letter was sent to the college vide Commission's letter of even no. dated 24.02.2022 to appear before the designated hearing committee dated 25.02.2022 in respect of appeal filed by the college under section 29(5) of National Commission for Indian System of Medicine Act, 2020.

The proceeding of appeal was held virtually on 25.02.2022 at 03:30 PM and on behalf of college, Dr. Vyankat, Director Medical and Dr. Kumudini Pawar, Principal attended the hearing. The hearing committee sought clarification from the representatives of the college regarding the denial order as well as shortcomings mentioned in the denial order dated 02.02.2022 passed by MARB Board which is as under:-

Shortcomings :-

1. Teaching Staff:-

- There is no Higher Faculty in the department of Ayurved Samhita Siddhant, Rachna Sharir and Kriya Sharir against the minimum requirement of 01 as per RMS 2016.
- Total teaching Staff is 57.14% against the minimum requirement of 90% as per RMS 2016.
- **Visitors submitted the list of 13 teachers (05 teachers in part 2 and 08 teachers in observation (including yoga teacher) teachers. Out of them 5 teachers are not considered. Details are as under:-**

Dr. Khandare Amit Chandrakant (Ayurved samhitasiddhant) relieved from B. R. Harne Ayurvedic Medical College, Vangani, Maharashtra on 31/12/2019. A copy of his Relieving cum experience certificate is attached for your kind perusal as Annexure 1. Dr. Khandare Amit Chandrakant Joined on 28/10/2021 as Lecturer/ Asst. Professor in the Department of Ayurved Samhita Siddhant of Mangalayatan Ayurveda Medical College & Research Center, Aligarh (MAMO & RC). A copy of his Joining letter is attached for your kind perusal as Annexure-2.

B. Dr. Khandare Amit Chandrakant after Joining, requested helpdesk of NCISM vide his mails dated 10/11/2021(10:08 PM), 05/01/2022 (12:24 PM), 15/01/2022(12:32 PM) to link his candidate with present institute (MAMC & RC). The copies of the mails are attached as Annexure - 3, 4 & 5. After his Joining MAMC & RC, the Principal of Mangalayatan Ayurveda Medical College & Research Center, Aligarh vide her mail dated 16/11/2021 (08:44 PM) sent the details of the faculty joined and with their status on teacher code. A copy of the mail and list are attached for your kind perusal as Annexure - 6 & 7.

C. Dr. Khandare Amit Chandrakant Joined on 28/10/2021 and is presently working as Lecturer/Asst. Professor in the Department of Ayurved Samhita Siddhant of Mangalayatan Ayurveda Medical College & Research Center, Aligarh (MAMC & RC) which can be confirmed from the videography and photographs taken during online visitation dated 26/11/21. A copy of the Photo graph taken on the eve of online visitation dated 26-12-21 is attached (with marking) as Annexure -8. The Annexure-I of the entire faculty including Dr. Khandare Amit Chandrakant with the supporting documents uploaded online and as advised by NCISM, all original Annexure - II of the faculty submitted on 21/12/2021 in your office (by hand). We are attaching the list of faculty (Department wise) presently on rolls with Mangalayatan Ayurveda Medical College & Research Center Aligarh is attached as Annexure 9 for your perusal. This list we have already submitted online on 19-12-21 and also hard copy on 21-12-21.

D. Mangalayatan Ayurveda Medical College & Research Center, Aligarh (MAMC &RC) is a New institute of Mangalayatan University, Aligarh (Rural). Due to lack of experience, we may not able to submit/upload the document properly for which we are deeply regretted and we request you to consider our application positively.

Observation of hearing committee :-

- Hearing committee asked clarification about non availability of Higher Faculty in the dept. of Ayurved Samhita Siddhant, Rachana Sharir and Kriya Sharir, in response of the same, College authority clarified that as per the relaxation policy issued by Ministry of AYUSH dated 26.03.2021 and 15.04.2021, i.e. if there is a shortage of Associate Professor = 2 Assistant Professors in addition to existing required faculty may be appointed and college has submitted that the college has 03 Lecturers in each department. Hence, college is fulfilling the criteria for the Teaching staff. Committee noted the same and informed the authority that committee will verify the same.
- Hearing committee informed that Dr. Diksha Dnyandev Sonawane, Dr Varun Tiwari and Dr Kumudini Pawar cannot be considered as Teachers are not included in first year Teaching staff and the same have been accepted by the College authority.
- Committee asked College authority about Dr. Amit Khandare, Lecturer, Ayurved Samhita Siddhant has submitted affidavit from other college for the session 2021-22, in response of the same Dr Amit Khandare cleared that he had resigned and got relieved on 31st Dec 2019 from previous college i.e. B. R. Harne Ayurved College, Maharashtra but could not be delinked that time and joined this college on 28.10.2021 and not attended any inspection for the session 2021-22. Committee assured that the matter will be verified. After verifying all the documents and record it is observed that the name Dr Amit Khandare has not found in Part-1 of any institution for the session 2021-22 and the name of the said teacher neither mentioned by the previous college B. R. Harne Ayurved College, Maharashtra nor in the affidavit submitted by the Teacher for the session 2021-22. Therefore committee recommends to consider Dr Amit Khandare as a Lecturer in the dept. of Ayurved Samhita Siddhant in the Mangalayatan Ayurveda Medical College and Research, Aligarh, UP.

- Committee asked College authority about Dr. Santosh Gadhe, Reader, Rachana Sharir per OTMS the mentioned experience is 4 years and 8 month- for which the Teacher be considered as a Reader, in respect of the same, college authority made appear Santosh Gadhe before the hearing committee and he submitted that by mistake he has not mentioned his previous experience in the OTMS hence the total experience has become less otherwise he has experience of more than 5 years at the time of Reader. After verifying all the documents and record (the visitation record of year 2014 he attended the visit dated 23.01.2014) it is observed that he has experience from Shri Bahubali Vidhyapeeth's J.V. Mandal's Grameen Ayurvedic Medical College, Terdal, Karnataka from 14.1.2013 to 06.06.2014 the committee agreed the same and considered him as a Reader in the dept. of Ayurved Rachana Sharir.

Hence, in view of above observation the committee recommends to consider the appeal of Mangalayatan University-Aligarh, 33rd Milestone Aligarh-Mathura Highway, PO: Beswan, Aligarh-202145, Uttar Pradesh to start a new Ayurveda Medical College in the name of Mangalayatan Ayurveda Medical College and Research Center, 33rd Milestone Aligarh-Mathura Highway, PO: Beswan, Aligarh - 202145, Uttar Pradesh with 60 seats in UG (BAMS) course for the session 2021-22.

Therefore, the recommendation of hearing committee was placed before Chairman, National Commission for Indian System of Medicine and it has been decided by the Chairman, NCISM **to consider the recommendation of hearing committee and to consider the appeal of Mangalayatan University-Aligarh, 33rd Milestone Aligarh-Mathura Highway, PO: Beswan, Aligarh-202145, Uttar Pradesh to start new Ayurveda College in the name of 'Mangalayatan Ayurveda Medical College and Research Center, 33rd Milestone Aligarh-Mathura Highway, PO: Beswan, Aligarh - 202145, Uttar Pradesh' with admission capacity of 60 seats in UG (BAMS) course under Section 29 of NCISM Act 2020 and relevant regulations thereunder, subject to the following conditions:-**


- The college shall submit an undertaking in the form of affidavit duly notarized within one month from the date of issue of the letter, explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying fee same as per the provisions of Employees' Provident Funds and Miscellaneous Provident Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.
- It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of undergraduate seats shall be treated as all India quota. The counseling for seats under all India quotas shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2021-22 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. **The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.**

Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.

Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.

The following requirements should be fulfilled by the college before the opening of Part-I visitation Proforma for the next academic year to get permission for the session 2022-23:

- all the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
- all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);

- (iii) all the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled in toto;

The college administration will ensure that sufficient qualified teachers and non-teaching staff in the college and requisite staff in the hospital, as per the NCISM ACT and relevant regulations thereunder, are in position before the admission of the first batch of students in the 1st professional of BAMS course is made, under intimation to the Medical Assessment and Rating Board, NCISM.

The college has to develop the requisite infrastructure for II, III and IV professionals well in time as per the erstwhile CCIM norms which will be verified by the Medical Assessment and Rating Board, NCISM and accordingly, the permission for taking admissions in subsequent academic session will be issued.

The college administration may take up the matter for recognition of the qualification under section 35 of the NCISM Act, 2020 at that time when the first, batch of students admitted against this course appears for the first final professional examination of the said course.

The fulfilment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission matter from the academic session 2022-23.

Further vide commission letter ref no. **3-4/2021-Ay (139)** dated **08.03.2022** letter has been sent to the college to furnish fixed security deposit worth rupees **01 Crore** in favour of National Commission fund for Indian system of Medicine. In response of the same college has furnished the fixed security deposit in favour of **The National Commission fund for Indian System of Medicine through transaction RTGS No. DFCR52022030952548963 (1 Crore) dated 09.03.2022 of 01 Crore transferred by HDFC BANK LTD, Sasni Gate Aligarh, UP for a period of five years.**


